All applications to the First Year Group or the Special Class (for ALL year groups) in Coláiste Dún an Rí will only be accepted after the 01 October 2024 and the closing date for receipt of applications is <u>3pm on the 24 October 2024</u>. Applications received after this date will be considered and processed as late applications in accordance with the school's Admission Policy.

All transfer applications to the Second, Third, Fourth, Fifth or Sixth Year Groups in Coláiste Dún an Rí other than to the Special Class, will only be accepted after the 21/04/2025 and the closing date for receipt of applications is the 13/05/2025. Applications received after this date will be considered and processed as late applications in accordance with the school's Admission Policy.

Please be reminded that, in line with the school's Admission Policy and the Education (Admission to Schools) Act 2018, all waiting lists going forward are only in place for the academic year to which they apply. Therefore, if a student is seeking a place in the Special Class and is not successful in a given academic year or is on a waiting list for this year, a new application must be made for the following year
